BACKGROUND

In the light of the conditions becoming increasingly difficult day by day for local life due to global climate change and man-made factors and continuously drying up water sources in the state of Uttarakhand in the last few decades, there is a need to identify the natural water sources and rainfed rivers of the state using scientific methods and achieve the goal of revitalization of rivers and continuous flow in water sources by treating them in a phased manner through various soil and moisture conservation interventions like- check dams, contour trenches, recharge pits etc. To achieve this, the interventions of various line departments needs to be integrated. In view of the, after due consideration, the government has decided to establish Spring and River

It will be the Nodal authority of the State for capacity development of various line departments, Institutes, N.G.O of the State and Watershed Department for Scientific planning, implementation & financing and monitoring & evaluation of Spring and River Rejuvenation programmes in the State of Uttarakhand.

Rejuvenation Authority (SARRA) under the Watershed Management Directorate.

DESCRIPTION

The purpose of establishment of Spring and River Rejuvenation Authority (SARRA) at State level is to identify all the water sources of the state which need to be rejuvenated on priority to ensure increase in water discharge and perennially of the spring and rainfed rivers. measurement and monitoring by ensuring community participation of local people for sustainable flow of rain-fed rivers etc..

COMPONENTS

The work to be performed by the mentioned authority (SARRA) will mainly be as follows:

- a) Assessment
- b) Planning and Financing
- c) Implementation
- d) Monitoring & Evaluation
- e) Capacity Development

NEED FOR CONSULTANCY SUPPORT

The key objective of the proposed consultancy is to assess the impact of springshed development initiatives mainly sustainability of the existing water sources, recharging, rejuvenating of water sources and benefits to the community for domestic and farming purposes including improvement in soil and moisture regime in the selected springsheds and rivers.

SCOPE OF WORK

- Design, develop and deploy efficient project MIS applications, SARRA website/dashboard and management of the database.
- Design and develop and IT based systems/dashboard for real time progress monitoring.
- The SARRA MIS should be capable of providing a quick analysis of progress, and trends against objectives.
- The MIS should have modules for data collection, editing, analysis of physical & financial activities.
- Maintain Interconnected network components, enable network operations, Management, and communication between internal and external systems.
- Maintain the network consistency of internet connectivity, network enablement, firewalls and security, as well as hardware like routers, switches, and cables.
- Provide training on MIS, ICT Tools and Dashboard for monitoring and implementation to SARRA officials as when required.
